



<b>Title</b>	<b>Courts and Administration – Administrative jurisdiction and judicial administration in a comparative perspective</b>

<b>Brief description</b>	The course aims at exploring the system of checks and balances between courts and administration. On the one hand, main aspects of judicial review will be treated in the matrix of access to court and effective judicial protection against administrative actions. On the other hand, the aspects of court administration will also be analysed, mainly focusing on the fair trial aspects, like independence and impartiality, as well as the questions of timeliness, case distribution and composition of panels. The case law of the ECtHR and ECJ as well as single member states' solutions are to be explored.
