INTRODUCTION AND CONFERENCE THEME

The **main theme of the conference is the autonomy of the individual**, a core concept across many interrelated scientific fields. In law, it is both a key aspect of the individual's protected private sphere and their capacity to make decisions that have legal effects. In public law, the question of decision-making capacity is linked to the exercise of fundamental and procedural rights, while states and supranational bodies have a duty to recognize and respect the decisions of individuals and their communities in a meaningful way. The papers presented at the conference approach this theme from a variety of perspectives, including administrative law, constitutional law, human rights law, and public international law.

The **keynote panel** of the conference will address the main theme from different perspectives. It will explore the issue of autonomous end-of-life decisions in a European context, present dilemmas arising from national and international judicial cases involving 'future generations', and analyze the impact of artificial intelligence on the exercise and protection of fundamental rights. Each of these topics raises pressing and timely issues, while also inviting reflection on fundamental theoretical questions.

The **panel on challenges related to legal capacity in the field of fundamental rights** will examine its theoretical background and doctrinal concept. It will illustrate these issues through examples such as children and persons living with cognitive disabilities, whose actual ability to exercise and enforce their rights may be hindered; the controversial legal status of state-related entities claiming the protection of fundamental rights; and the emerging recognition of the status of nature, which is increasingly appearing in legal disputes challenging the obligations of states and the international community.

The **plenary session on Academic freedom and social responsibility** will reflect the current challenges facing the academic world. As a global phenomenon, national governments often seek to directly influence the activities of academic institutions through communicative and financial threats against certain fields of research, as well as by curtailing institutional autonomy. On the other hand, the social credibility of science is weakened for various reasons. The panel will address these issues, as well as the responsibility of members of the scientific community to reflect on the various contemporary challenges facing the societies in which they live. The **parallel sessions** of the conference are organised into **five thematic streams**, each of which focusing on a particular, timely aspect of public law: *Concepts and doctrines in fundamental rights protection, Rights of vulnerable people and their safeguards, New challenges in fundamental rights protection, The protection of the judiciary and the rule of law, Crises and democratic challenges*. Over the two days, twenty-seven parallel sessions will take place in six timelines, in each timeline with sessions linked to the thematic streams. Following one or more of the thematic streams will provide a deeper insight into current theoretical and practical issues in the related field of public law.

A **side event** will focus on **creativity in academia** as an essential skill related to teaching and research activities. The informal discussion will look at possible obstacles and ways in which creativity can be rediscovered and practiced.
