

Title	European rule of law mechanisms

Brief description	This course provides a comprehensive examination of the European Union's mechanisms for upholding the rule of law— a foundational yet increasingly contested principle within the EU's legal framework. Students will trace the conceptual evolution and core elements of the rule of law, examine the causes and scope of the ongoing rule of law crisis in the EU, and critically assess the institutional responses developed in recent years. Through an in-depth analysis of both preventive and enforcement tools—including the EU Justice Scoreboard, the Rule of Law Cycle, Article 7 procedures, infringement and preliminary reference procedures, and conditionality mechanisms tied to EU funding—students will gain a clear understanding of how the EU seeks to monitor, protect, and sanction breaches of rule of law standards among Member States. Coursework involves active class participation, a written critical evaluation of a selected EU rule of law mechanism, and a final test. Readings include excerpts from foundational EU law texts and recent scholarly work, supplemented with official EU resources. By the end of the course, students will be equipped to critically analyze the strengths and limitations of the EU's rule of law toolbox and engage with key legal and political debates shaping the future of European integration.
