Call for papers

The Hungarian ELI Hub under formation and the Jean Monnet Centre of Excellence operated in the framework of the Department of Private International Law and European Economic Law of the Faculty of Law, Eötvös Loránd University, Budapest (<u>https://www.ajk.elte.hu/en/jeanmonnet</u>), as hosts, are proud to present a **joint call for papers for the 1st International Forum of the Hungarian ELI Hub.** The Forum will be held at the Faculty of Law on the 14th of September 2018.

Background

The European Law Institute (ELI) in Vienna aims to improve the quality of European law, understood in the broadest sense. It seeks to initiate, conduct and facilitate research, to make recommendations, and to provide practical guidance in the field of European legal development. The first preparatory steps of the Hungarian Hub of the European Law Institute (ELI) has been approved in March 2018 by the Executive Committee of ELI. The main aim of the present International Forum is to officially endorse the estblishment of the Hungarian ELI Hub in the framework of a conference which seeks to contribute to discovering the impact and effects of Brexit on both EU Law and UK Law – in theory and in practice.

Concept and main topics

The Brexit referendum in 2016 marked a symbolic turning point in the history of European integration. Britain's impending departure gave rise to political, economic and identity debates. The ongoing negotiation process continuously sparks controversies at the level of the law, being related to citizenship rights, fiscal issues, trade in general, the Internal Market, as well as justice and home affairs or security and foreign policy. The whole process also serves us with many ideas regarding the future contractual relations between the EU27 and the UK. Our International Forum aims at providing opportunity for representatives of all areas of EU law to share their views on these aspects. Special focus would be put on the effect of Brexit on Hungary and the Central and Eastern European region. Selected studies on Brexit have already been published in the ELTE Law Journal in the spring of 2017 (http://eltelawjournal.hu/) which might provide basis for further discussions. We strive for drawing a horizontal picture and do not want to be too specific. Depending upon interest separate sessions will be formed during the Forum, if necessary.

Submission guidelines

The Organising Committee invites both junior and senior scholars – including PhD students – to participate at the call for papers of the 1st Hungarian ELI HUB International Forum. Paper abstracts shall not exceed 300 words and be submitted in DOC or PDF document to the Organising Committee at <u>hungarian.eli.hub@ajk.elte.hu</u>. The deadline for submission is **20 May 2017**. In addition to the abstract, short information is awaited on the name, affiliation and contact details of the author.

Proposals will be selected on the basis of the submitted abstracts and successful applicants will be informed by 15 June 2017. The draft programme of the Forum, including forming sessions if necessary, will be published by July 2018. The draft papers should be sent to the Organising Committee until 30 August 2018 and completed for publication upon the end of September.

Publication of the papers

The Jean Monnet Centre of Excellence at ELTE will provide opportunity for publication. Selected papers will be published in both hard copy and e-book format of the ELTE Law Journal in its volumes in 2018/2019.

15 June 2018 – Notifications sent on the accepted papers
15 July 2018 – Finalisation of the programme of the Forum
30 August 2018 – The deadline for the submission of the draft papers
14 September 2018 – 1st International Forum of the Hungarian ELI Hub
30 September 2018 – Submission of the final versions of the papers for publication
